Students selected through NCHM JEE are requested to deposit remaining 1st Semester fee of Rs. 34,700/- (Total Semester fee Rs. 74,700/- minus Rs. 40,000/- already paid) by online transfer or by submitting Demand Draft by 8th November,2021. - 5. Students willing to stay in Boys/ Girls Hostel are requested to submit their request with the transaction number and other details of hostel fees payment or carrying a Demand Draft of Rs. 70,000/- (for whole year) on 7th November, 2021 after lunch to occupy hostel.

- k) Undertaking, if any (Submitted during 1 to 3" Round of Counselling)
- I) Duly filled in Admission Form of the Institute (to be downloaded from our website)
- m) 1st Semester remaining fee receipt of Rs. 34,700/-
- n) Hostel & Mess fee receipt of Rs. 70,000/- for shared accommodation (if hostel allotted).
